TEACHING EVALUATION

Dr. Breanna (Bree) Bopprie (pronounced Bo-Prey) has spent the past 15 years leading mixed methods research and evaluation on correctional programs, community-led prevention efforts, and sentencing policies. She specializes in community-engaged participatory methods to engage youth, women, and families impacted by the criminal legal system. Her work incorporates an intersectional racial equity lens to address gendered, racial, and ethnic disparities in admissions and outcomes.

Over the course of her career, she has authored over 70 publications, including 22 peer-reviewed journal articles in top outlets such as *Justice Quarterly*, *Crime & Delinquency*, and *Criminal Justice and Behavior*. She is a nationally recognized expert for her scholarship on women and families impacted by the criminal legal system. She has earned multiple national awards including the American Society of Criminology (ASC) Division of Feminist Criminology New Scholar Award and Western Society of Criminology Meda Chesney-Lind Award. Bopprie is committed to supporting the translation of research to practice. She has collaborated with over 30 correctional agencies, nonprofits, and grassroots organizations through applied collaborative research, interactive workshops and trainings, hands-on technical assistance, and service-learning partnerships. Dr. Bopprie has delivered over 70 presentations, including invited mainstage/keynote talks for the American Probation and Parole Association and Western Association of Criminal Justice. Her work has led to actionable changes in training approaches, program design, state visitation practices, and sentencing reform.

Having [experienced parental incarceration herself](#), Dr. Bopprie prioritizes scholarship to improve policies and programs for system-impacted people and their families. She co-founded and co-leads the ASC Division on Convict Criminology Mentoring Program, which connects system-impacted mentors and mentees across the world through an inclusive formal mentorship program.

Currently, Dr. Boppre is a Senior Research Associate in the Justice and Safety Division at the [Urban Institute](#), a nonpartisan nonprofit research institute based in Washington DC. At Urban, Dr. Boppre co-leads multiple mixed methods studies funded by federal and philanthropic organizations evaluating youth prevention and correctional programs and policies. Most recently, she co-led a national scan of state approaches to keep young people out of detention for status offenses and case studies of promising practices in two states, funded by the National Institute of Justice. She also co-led the [Catalyst Grant Program](#), funded by the Microsoft Justice Reform Initiative, providing technical assistance to local nonprofit organizations using data and technology to support front-end reforms to the criminal legal system.

Prior to joining Urban, Dr. Boppre worked in higher education as an award-winning faculty member in the nation's first Department of Victim Studies at Sam Houston State University. She has received teaching awards at the departmental, university, and national levels in recognition of her inclusive, engaging, and innovative teaching methods, including the Academy of Criminal Justice Sciences Ken Peak Innovations in Teaching Award for her infographic assignment. She continues to teach criminology courses as an adjunct professor for Colorado State University.
